- b. **Transportation-** I attended the second State Accessibility Advisory Committee (AAC) meeting on January 16<sup>th</sup> at the request of Shawn Murinko of Washington DOT .

- e. **Deinstitutionalization.** Met with Liz Prince on October 27, 2008 to discuss updates on Roads to Community Living. Statewide, There have been approximately 80 individuals have moved from institutions to community-based living options.
